- Participants must be a City of Ames Electric Services customer.
- Maximum incentive cap of \$2,000 per general power customer or \$5,000 per large power/industrial customer shall normally be in affect.
- Incentives that exceed maximum caps, or compact fluorescent lamp quantities greater than 100, may be approved on a case-by-case basis by City of Ames Electric Services. **Please call 239-5177.**
- Rebates are for efficient interior lighting only.
- For non-prescriptive lighting systems (those not listed on the claim form) a custom incentive will be paid based on two year energy savings.
 - (Kilowatts saved) x (number of units) x (annual operating hours) x (current kWh rate).
- Rebate amount will not exceed equipment cost per unit.
- Equipment must be installed and operating prior to submission of application. All rebate payments are subject to inspection and verification.
- Replaced lighting materials may contain hazardous waste and must be disposed of properly.
- An itemized and dated invoice from the contractor must accompany the equipment application.
- Applications must be completed in full, incomplete applications will delay processing and may be returned. Rebates are based on the rebate schedule in effect on the date of dealer invoice.
- Applications must be submitted within 30 days of equipment installation unless otherwise authorized.
- Rebate checks will be issued to account holder in existing buildings unless otherwise established prior to submission of application. Checks will be issued to builder/general contractor in new buildings unless otherwise established prior to submission of application.
- City of Ames Electric Services reserves the right to install a metering device on new equipment to verify energy savings.
- Rebates may be subject to income tax. Consult your tax advisor for more information.
- Rebates are subject to availability of funds.
