- Renters must have owner's approval.
- Participant will be contacted to establish a time for the audit.
- Participant will be contacted to establish a time for the blower door test.
- Audits are performed on a first come, first served basis. At times a waiting list may exist.
- City of Ames Electric Services reserves the right to install a metering device on new equipment to verify energy savings.
- Energy audits are subject to the availability of funds.
