- All rebate payments are subject to inspection and verification.
- **To be eligible for an incentive the home must be EnergyStar® certified and proof must accompany this claim form.** Certification must be provided from a RESNET certified HERS rater showing the home meets or exceeds EnergyStar® standards. Other forms of certification must be approved by City of Ames Electric Services in advance.
- Claim forms must be completed in full, incomplete applications will delay processing and may be returned.
- Rebates are based on the rebate schedule in effect on the date of dealer invoice.
- Claim forms must be submitted within 30 days of home completion unless otherwise authorized.
- Rebate checks will be issued to builder/general contractor in new homes unless otherwise established prior to submission of claim.
- **On all new residential construction the home is automatically enrolled in City of Ames Electric Services' Prime Time Power program and will have a load control switch installed on its central air conditioner.**
- City of Ames Electric Services reserves the right to install a metering device on new equipment to verify energy savings.
- Rebates may be subject to income tax. Consult your tax advisor for more information.
- Rebates are subject to availability of funds.
