  - c. Collection Management: Theresa Stromberg-Murphy has been reviewing what has already been done RE GIS project and then plans to convene the committee

- VI. Chair's report: Octagon Art Festival September 24th. PAC is hosting a booth and volunteer support is needed.
- VII. Liaison Comments: No significant additions other than what is in agenda.
- VIII. Old Business:

- d. AMES project: draft proposal to be discussed with CyRide was included in the agenda of the meeting. City "right of way" policy establishes the area eligible for art installation.
