

Ames Public Access Television Program & Warranty Agreement

THE UNDERSIGNED, _____,
being the producer or sponsor of the program entitled,
_____, warrant and represent to Ames Public Access
Television (APATV) that the program listed which is submitted by me does not contain
any of the following:

1. any material that is libelous, slanderous, or defamatory;
2. any material that is an unlawful invasion of privacy;
3. any material that violates local, state, or federal laws relating to obscenity and/or indecency;
4. any unlawful use of copyrighted material;
5. any advertising or material that promotes any commercial product or service;
6. any solicitation or appeal for funds;
7. any material contrary to applicable local, state, or federal laws.

These warranties and representations are made by me in order that this program be
cablecast on the Ames Public Access channel. I further agree, to the extent allowed by
law, to indemnify and hold harmless APATV, the City of Ames, Mediacom
Communications Corporation, and any of their employees, officers, board of directors,
commissioners, stockholders, etc., from any and all claims, demands, damages or other
liabilities which may be made against or arise out of the cablecast of the program
submitted by me whether or not the program has been reviewed by APATV staff prior to
cablecast.

I have read the instructions for program submission and further understand any violation
of this agreement will result in the cancellation of privileges to airtime provided by Ames
Public Access Television, and may result in legal action which could include fines and
imprisonment. I also understand that this Program Agreement is subject to the Open
Records Act and may be released as a public document.

Instructions for program submission:

1. Program MUST be accompanied by a signed Program Agreement. Submit forms to the City Manager's Office in Ames City Hall at 515 Clark Avenue.
2. Program must meet technical standards requirement and electronic files must be labeled with program title and total running time (duration of the event/show).
3. Final decisions regarding specific airtime(s) are made by APATV programming staff.
4. In the event that APATV staff receives a complaint which indicates that the Program Agreement has been violated, the producer/sponsor agrees to allow APATV staff to retain and review any tape or production related material which was submitted by the producer for cablecast on the Ames Public Access channel. The producer further agrees that program playback will be postponed until APATV staff can verify contract compliance. If the material in question has been returned to the producer prior to the receipt of the complaint the producer agrees to allow APATV staff to review the material the next time it is submitted for cablecast.

I have read, understand, and agree to the conditions as outlined in these instructions for program submission.
