- 2. Program must meet technical standards requirement and electronic files must be labeled with program title and total running time (duration of the event/show).
- 3. Final decisions regarding specific airtime(s) are made by APATV programming staff.
- 4. In the event that APATV staff receives a complaint which indicates that the Program Agreement has been violated, the producer/sponsor agrees to allow APATV staff to retain and review any tape or production related material which was submitted by the producer for cablecast on the Ames Public Access channel. The producer further agrees that program playback will be postponed until APATV staff can verify contract compliance. If the material in question has been returned to the producer prior to the receipt of the complaint the producer agrees to allow APATV staff to review the material the next time it is submitted for cablecast.
