- An itemized and dated receipt or invoice.

**Terms and Conditions**

- Each request for rebate will be evaluated on a case-by-case basis.
- Incentive will be equal to 30% of the cost of correction equipment not to exceed \$70 per KVAR. An estimate of the installed cost per KVAR corrected must accompany the claim form.
- Cases where the incentive is estimated to exceed \$15,000 will be evaluated on a case-by-case basis and must be pre-approved by City of Ames Electric Services.
- Rebates are for power factor correction equipment only.
- Rebate amount will not exceed Electric Services' cost for correction.
- City of Ames Electric Services reserves the right to verify corrected power factor.
