SUMMARY

December Training: All officers attended CPR Training. Three officers graduated from the Iowa Law Enforcement Academy and resumed their field training. One officer assisted the Iowa Law Enforcement Academy with Operating While Intoxicated (OWI) training. One officer assisted in domestic assault training scenarios at the Iowa Law Enforcement Academy. All shift officers attended sexual assault training completed by the U.S. Army. Several officers attended defensive tactics training.

December Outreach and Engagement: Officers and their families assisted with the annual Shop with a Cop event. Officers from ISU and Story County also helped make this another successful year. Officers attended the Menorah lighting held downtown at Tom Evans Plaza. Ames High School outreach included a visit from officers who brought donuts to the classroom. Officers completed bank safety talks with two local banks.

USE OF FORCE DETAIL

Incident 1: 24004477

Use of Force: Pointed Taser

Date: December 8, 2024, at 02:08

Details: Officers were dispatched to a report of a burglary. An officer located the suspect and attempted to take him into custody. The man fought and punched the officer and started to run away. The officer pointed their Taser but did not deploy it. Another officer arrived on scene and also pointed their Taser at the man. The man gave up and was arrested and placed into custody.

Charges: Assault on a Peace Officer, Burglary 2nd Degree, Criminal Mischief 3rd, Public Intoxication, Interference with Official Acts

Demographics: 34-year-old white male

Incident 2: 24004494

Use of Force: Pointed Taser

Date: December 9, 2024, at 09:53

Details: Officers were dispatched to a school where a student was suffering a mental health episode and needed to go to a medical facility for evaluation. Officers, school staff, and medical personnel all attempted to deescalate the male. The student was violent so officers grabbed the subject and took him to the ground where he could be safely secured for transport and to stop the potential for others being harmed.

Charges: No Charges

Demographics: 14-year-old white male

Incident 3: 24004533

Use of Force: Pinned against wall, grabbed

Date: December 12, 2024, at 14:21

Details: An officer located a man with an active arrest warrant. The officer notified the man he was under arrest and the man tensed up and refused to allow the officer to place him in custody. The officer pinned the man against a wall and waited for back up to arrive. At that point, officers were able to place him in handcuffs.

Charges: Warrant Arrest, Interference with Official Acts
Demographics: 59-year-old white male

Incident 4: 24004739

Use of Force: Pointed Taser

Date: December 27, 2024, at 01:48

Details: An officer was dispatched to a convenience store where it was reported a female was hitting a male with a sign inside the store. As the officer arrived, the female came out of the store still obviously upset. The officer pointed a Taser at the female and ordered her to stop. The female complied and the officer investigated the original call finding this was a domestic situation. She was placed under arrest for Disorderly Conduct.

Charges: Disorderly Conduct
Demographics: 35-year-old black female

Incident 5: 24004757

Use of Force: Drew Taser

Date: December 28, 2024, at 14:02

Details: Officers were dispatched to Douglas and Main Street for a report of a man standing in the street, yelling and refusing to move. Officers arrived and were familiar with the man. He took up a fighting stance when he saw the officers. One officer drew their Taser, but did not deploy it. Another officer was able to safely handcuff the man who was taken into custody.

Charges: Disorderly Conduct/Pedestrian Failing to Use Crosswalk
Demographics: 41-year-old-black male

Incident 6: 24004767

Use of Force: Grabbed subjects

Date: December 29, 2024, at 07:46

Details: Officers located two juveniles who had stolen a vehicle from a neighboring jurisdiction at a local convenience store. Both juveniles attempted to flee, and officers grabbed them to place them in custody. During a search, marijuana was found on one of the juveniles. The neighboring jurisdiction handled the stolen vehicle case with other charges.

Charges: Possession of a Controlled Substance, Harassment 2nd Degree
Demographics: 15-year-old black male/17-year-old-black male

Incident 7: 24004769

Use of Force: Drew Duty Weapon

Date: December 29, 2024, at 12:53

Details: Officers were called to a residence for a violation of a protective order. It was reported the female violating the order was armed with a knife. Officers attempted to locate the female, and an officer drew their duty firearm when the female was located hiding. She followed orders and was taken into custody.

Charges: Contempt of Court/Violation of a No-Contact Order
Demographics: 25-year-old black female

Incident 8: 25000004

Use of Force: Grabbed subject

Date: December 31, 2024, at 23:21

Details: Officers responded to a medical call at a private residence for an alcohol overdose. There was a large party. Officers had responded to a similar call in the past of a large underage party where alcohol was available. Several underage and under 18 individuals were located in possession of alcohol. The host of the party was identified and officers attempted to place her under arrest for allow minors to possess and consume alcohol. As the officers tried to handcuff her, she kicked one officer and bit another. Officers grabbed her and were able to control her, however, she kicked one of the officers again as they attempted to place her in the patrol car.

Charges: Assault on a Peace Officer-2 counts, Permit Person Under 18 to Consume/Possess Alcohol, Nuisance Party, Interference with Official Acts

Demographics: 57-year-old white female

*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.


Arrests by Race/Gender






Manner of Crash








Surface Conditions







Injury Status




Vehicle Action


