
**Use of Force Incidents: 4**



### **USE OF FORCE DETAIL**

### Incident 1:

### Use of Force: Grabbed subject, Display of firearm

Details: Officers were dispatched to a local neighborhood regarding a suspicious male who was entering and exiting garages. The caller lived in the neighborhood and knew the male was not a resident of the homes in which he was entering. The caller provided the name of the suspect. The Communications Center found the male was wanted by another agency and was known to be armed. An officer drew their firearm and pointed it at the male who had exited a garage and was in the front yard of one of the residences. The male was ordered to get on the ground. The man complied and the officer holstered the firearm and secured him in handcuffs.

Charges: Criminal Trespass, Arrest Warrant-Other Agency

Demographics: 34-year-old white male

### Incident 2:

### **Use of Force: Grabbed subject**

Details: Officers were on routine patrol when they located a male passed out near a local business. Officers attempted to wake the male, but he did not respond. Officers called for an ambulance due to the male's level of consciousness and intoxication. Officers turned the male over to medical personnel. However, the male became uncooperative and medical personnel requested officer assistance. Officers attempted to assist in getting the male in the ambulance, but he fled. The male was ultimately apprehended after falling a short distance away from the ambulance. Officers grabbed the male and secured him in handcuffs. After being evaluated at a local hospital, the male was taken to jail. One officer sustained a minor injury to their elbow and knee.

Charges: Public Intoxication, Interference with Official Acts, Misuse of License or ID Card to Acquire Alcohol Demographics: 20-year-old white male

### Incident 3:

### Use of Force: Grabbed subject

Details: Officers responded to a local business reference a suicidal female. Officers grabbed the female and escorted her out of her vehicle and away from the knife she said she had. The female was taken to a local hospital on an involuntary committal.

Charges: No charges

Demographics: 31-year-old white female

### **Incident 4:**

### Use of Force: Grabbed subject

Details: Officers responded to a local apartment complex in reference to a male who had knocked on the caller's door and asked about his wife and child. The caller told the male to leave, as he did not know the male. The male later returned and knocked on the door again and tried the door handle, which was locked. Officers located the male who refused to stop and talk with officers. Officers grabbed the male and placed him under arrest.

Charges: Harassment 3<sup>rd</sup> Degree

Demographics: 45-year-old white male

\*A note on arrests and charges. There is a difference between a discretionary and a non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused


