


Events by Day

Officer Involved




Events by Hour - All Days

USE OF FORCE DETAIL

Incident 1:

Use of Force: Grabbed subject

Date: June 1, 2025, at 00:49

Details: Officers responded to a report of a male pacing back and forth and yelling at an intersection. Officers tried to deescalate the male but were unsuccessful. Officers grabbed the male to secure him as he continued to be disorderly. The male fought with officers, so officers took him to the ground to place him in custody. Two officers were injured during the arrest.

Charges: Disorderly Conduct-Loud Raucous Noise, Interference with Official Acts

Demographics: 58-year-old black male

Incident 2:

Use of Force: Displayed firearm \grabbed subject

Date: June 1, 2025, at 23:26

Details: Officers conducted a traffic stop on a vehicle with no plates. The vehicle attempted to elude officers before stopping in a motel parking lot. Officers displayed their firearms as they approached the driver of the vehicle who refused to comply with commands. The female driver refused to exit the vehicle. Officers grabbed her and placed her in custody.

Charges: Eluding, Failure to Prove Security Against Liability, Operation without Responsibility

Demographics: 39-year-old white female

Incident 3:

Use of Force: Grabbed subject

Date: June 3, 2025, at 21:35

Details: Officers responded to a medical facility to assist with a suicidal juvenile who had run away. Officers located the male at a convenience store and attempted to deescalate him. The male refused to cooperate. Officers grabbed the male to prevent him from running. The male was combative, so he was secured in handcuffs. Officers returned the male to the medical facility where he was removed from handcuffs and turned over to staff for treatment.

Charges: None

Demographics: 14-year-old white male

Incident 4:

Use of Force: Grabbed subject

Date: June 4, 2025, at 16:37

Details: Officers responded to a residence for a report of an assault. Officers located the male suspect and began speaking with him. The male picked up rocks and a golf club and began threatening to harm officers. Officers were able to secure the male in handcuffs, but he refused to get into the patrol car. Officers took the male to the ground to prevent him from hurting himself or the officers. The male was ultimately placed in the back of a squad car. The male caused damage to the rear of the squad car during transport to the jail.

Charges: Assault Causing Bodily Injury or Mental Illness, Criminal Mischief 2nd Degree, Interference with Official Acts

Demographics: 26-year-old white male

Incident 5:

Use of Force: Displayed firearm

Date: June 15, 2025, at 18:32

Details: Officers responded to a residence for a disorderly conduct call involving a weapon. Officers were told the suspects left the scene in a vehicle. The suspect vehicle was located. Due to the nature of the call for service, officers initiated a high-risk traffic stop on the suspect vehicle. Officers had their handguns drawn as they ordered the occupants out of the vehicle. Upon securing the individuals, no other use of force was needed.

Charges: Case remains under investigation

Demographics: 45-year-old unknown male

Incident 6:

Use of Force: Grabbed subject

Date: June 24, 2025, at 00:22

Details: Officers responded to a convenience store for suspicious activity. Officers located several individuals in the area as well as someone who appeared to be having a medical problem in her vehicle. Officers found the female to be intoxicated. She was advised she was not able to drive home but could find a ride. The female stated she would walk home. However, the female did not walk home and instead became disorderly and began fighting officers. Officers took the female to the ground as she was kicking them and thrashing.

Charges: Assault on a Peace Officer or Firefighter, Public Intoxication, Interference with Official Acts

Demographics: 28-year-old white female

Incident 7:

Use of Force: Grabbed subject

Date: June 24, 2025, at 02:04

Details: Officers responded to a convenience store to take a report of a male hitting his children and pushing the caller. The caller and children had fled from the assault to meet with officers. Officers observed injuries on one of the children. A short time later, the male was located at his residence. The male fought with officers and was taken to the ground. While officers were getting the male into the squad car for transport, the male kicked one officer in the arm, and another officer in the face. Officers eventually got the male secured in the back of the squad car and transported him to the Story County Jail.

Charges: Domestic Abuse Assault-1st Offense, Child Endangerment with Bodily Injury, Child Endangerment with No Injury, Interference with Official Acts with Injury, Assault on Person's in Certain Occupations x 2

Demographics: 31-year-old white male

Incident 8:

Use of Force: Grabbed subject

Date: June 24, 2025, at 17:54

Details: Officers responded to a local residence for a juvenile female who had taken an unknown amount of prescription medications along with other unknown substances. Officers waited with the female until fire and EMS personnel arrived. As the female was being loaded into the ambulance to be taken to a medical facility for treatment, she bit one of the medics. Officers assisted medics and fire personnel with restraining the female's extremities as they prepped her for transport.

Charges (Juvenile Referral): Assault on Person's in Certain Occupations

Demographics: 16-year-old white female

Incident 9:

Use of Force: Grabbed subject

Date: June 27, 2025, at 09:15

Details: Officers attempted to conduct a traffic stop. The driver refused to pull over and continued driving until arriving at a local apartment complex. The male juvenile refused to identify himself and would not get off the vehicle. Officers grabbed the male and secured him in handcuffs to be transported to the PD. The male was in possession of a vape. The male was issued juvenile referrals and turned over to his guardian.

Charges: Failure to Yield to Emergency Vehicle, Possession of Tobacco Under Legal Age, Harassment of Public Officials and Employees, Interference with Official Acts

Demographics: 16-year-old white male

*A note on arrests and charges. There is a difference between a discretionary and a non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.


