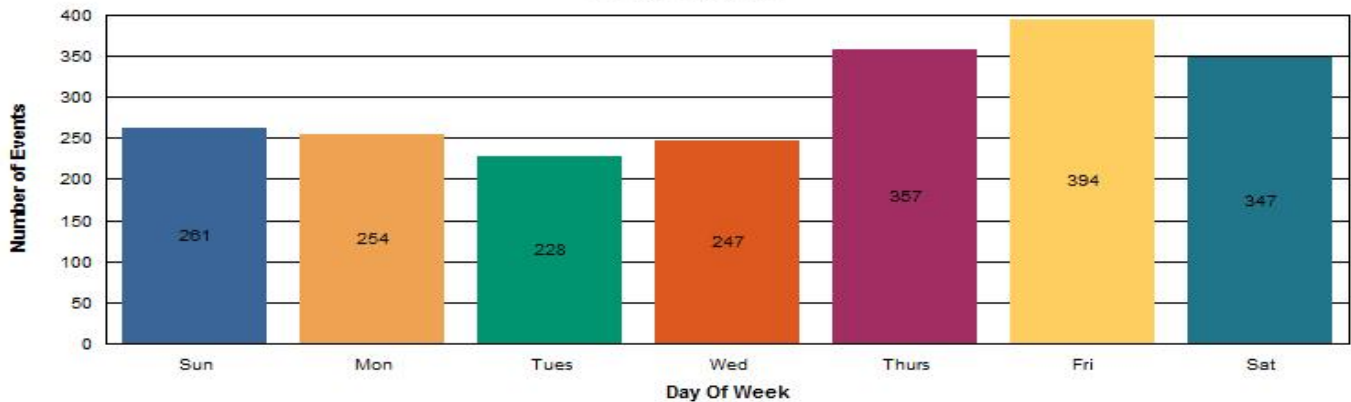

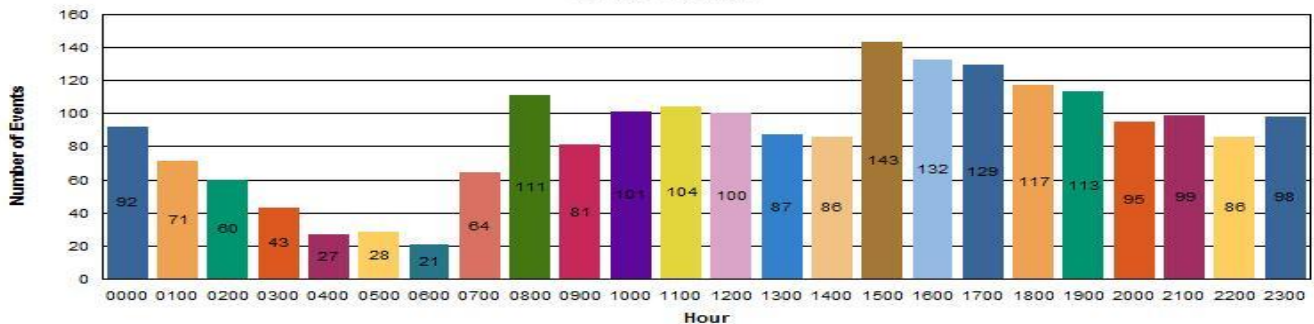
Events by Day

Officer Involved



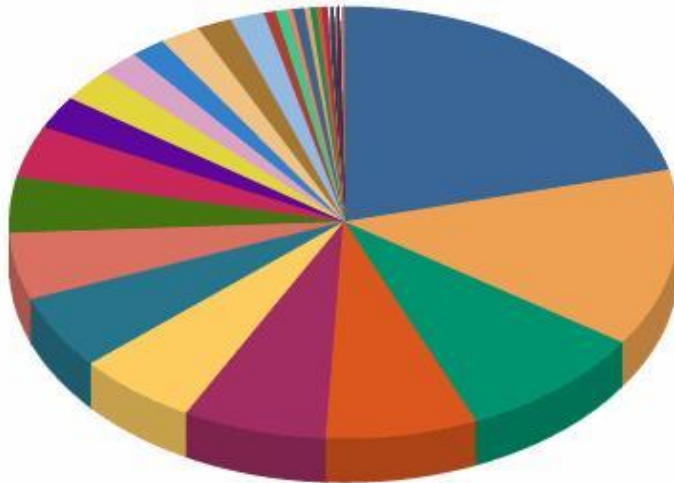
Events by Hour - All Days

USE OF FORCE DETAIL

Incident 1:

Use of Force: Grabbed subject

Date: May 15, 2025, at 03:32

Details: Officers responded to a disorderly call from a female at a parking garage. Officers attempted to deescalate the female but due to her level of intoxication officers were unsuccessful. The female attempted to jump in front of a moving truck. Officers grabbed the female and guided her to the ground to place her in custody for her safety.

Charges: Simulated Public Intoxication

Demographics: 24-year-old black female

Incident 2:

Use of Force: Grabbed subject

Date: May 19, 2025, at 15:30

Details: Officers responded to a residence for an out-of-control female juvenile who was kicking and throwing things at her mother. As family was working to get the female juvenile to the hospital for mental health treatment, the female juvenile's sister became upset and aggressive. Officers grabbed her to move her out of the way. She was later released to family with no charges.

Charges: No charges

Demographics: 10-year-old white female, 13-year-old white female

Incident 3:

Use of Force: Grabbed subject

Date: May 28, 2025, at 19:50

Details: Officers responded to a business for a civil matter. A female who was found to be intoxicated was unhappy with the service she received from the establishment. She was asked to leave the establishment, but she refused. She attempted to flee from officers, but due to her intoxication, she was grabbed and taken to the ground to be secured in handcuffs after refusing to surrender her hands.

Charges: Disorderly Conduct, Public Intoxication, Trespass

Demographics: 25-year-old white female

Incident 4:

Use of Force: Grabbed subject

Date: May 29, 2025, at 21:55

Details: Officers responded to a gas station for a female juvenile who had stolen alcohol, locked herself in the bathroom, and was consuming the alcohol. Officers located the female in a locked stall consuming the stolen alcohol. Officers opened the stall, and the female became combative and began kicking officers. Officers grabbed her and placed her in handcuffs. She was taken to a hospital for treatment.

Charges: Theft 5th Degree, Public Intoxication, Possession of Alcohol by Person Under 21, Assault on Peace Officer

Demographics: 15-year-old white female

Incident 5:

Use of Force: Grabbed subject

Date: May 30, 2025, at 01:16

Details: Officers responded to a residence for a female who was intoxicated and who had assaulted several people. Officers located the female outside and determined she was highly intoxicated. She attempted to get away from officers and she was grabbed and placed in custody.

Charges: Public Intoxication, Interference with Official Acts

Demographics: 18-year-old white female

*A note on arrests and charges. There is a difference between a discretionary and a non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.

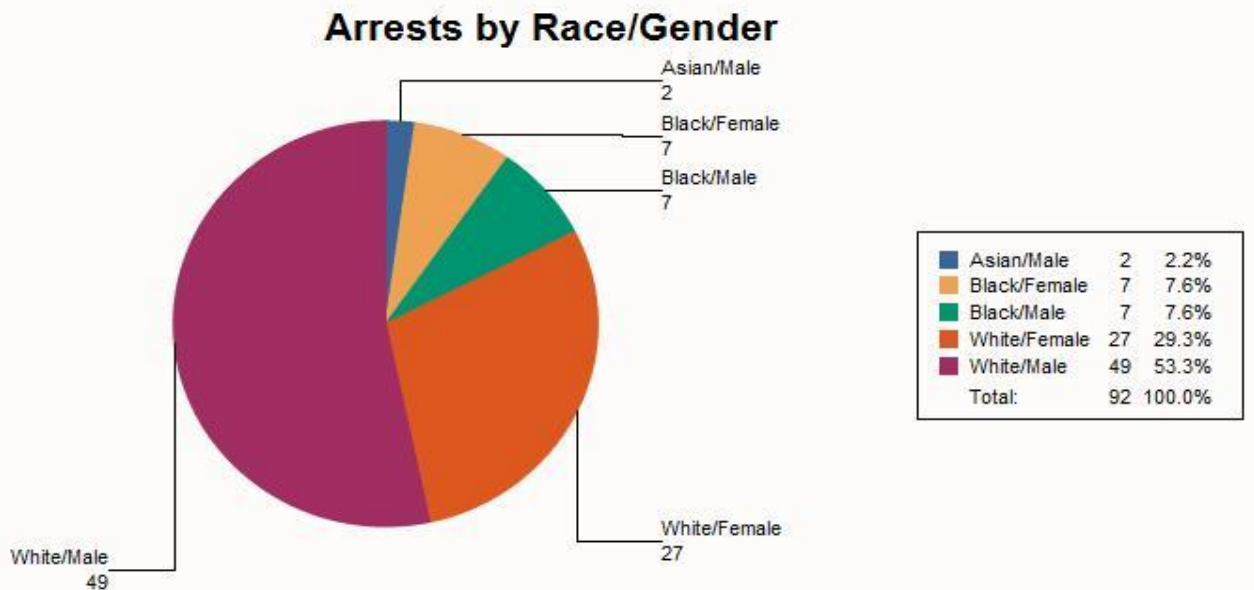
