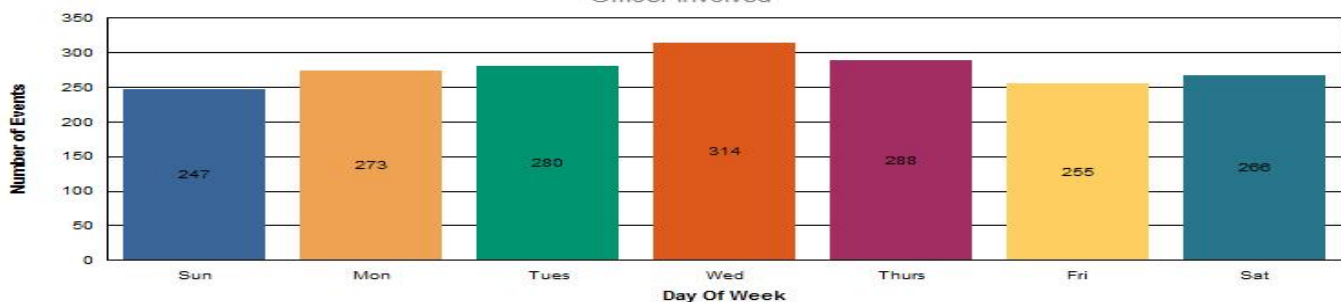

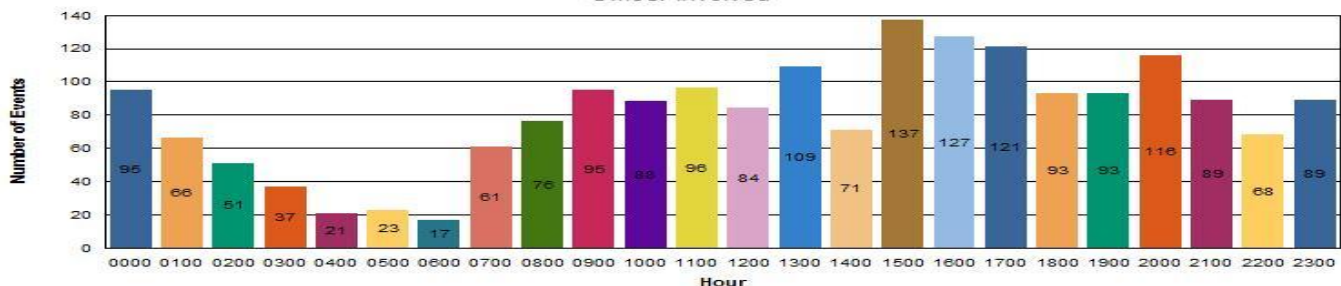
Events by Day

Officer Involved



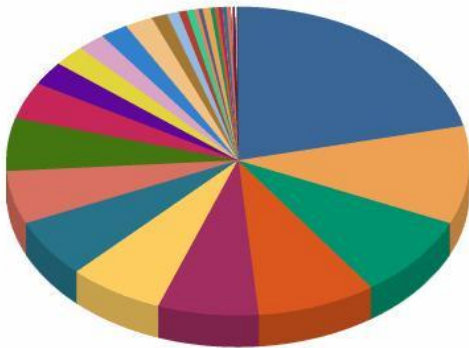
Events by Hour - All Days

USE OF FORCE DETAIL

Incident 1:**Use of Force: Grabbed subject****Date: April 7, 2026, at 00:43**

Details: Officers were dispatched to a gas station after receiving a report of a male who had locked himself out of his vehicle and was causing a disturbance by demanding rides from patrons and throwing items. Officers contacted the male and determined he was intoxicated. When officers attempted to take the male into custody, he resisted. Officers gained control by grabbing the male and secured him in handcuffs.

Charges: Public Intoxication, Disorderly Conduct, Possession of Controlled Substance

Demographics: 22-year-old black male

Incident 2:**Use of Force: Grabbed subject, Deployment of pepper spray****Date: April 14, 2026, at 12:52**

Details: Officers took a harassment report from a victim who reported a male had threatened to burn their house down. Officers determined the male had active arrest warrants from another agency. Officers later located the male at a nearby business. When officers attempted to take the male into custody, he physically resisted. During the ensuing altercation, officers deployed pepper spray. The male was taken to the ground and ultimately secured in handcuffs.

Charges: Arrest Warrant, Harassment 1st Degree, Interference with Official Acts

Demographics: 34-year-old black male

Incident 3:**Use of Force: Grabbed subject****Date: April 17, 2026, at 01:25**

Details: Officers were leaving a local establishment when they observed a fight involving four individuals. Officers grabbed one male and took him to the ground to prevent further escalation of the physical altercation. All four individuals involved were arrested.

Charges: Public Intoxication, Disorderly Conduct

Demographics: 21-year-old Asian male, 21-year-old Asian male, 21-year-old white male, 22-year-old unknown male

Incident 4:**Use of Force: Grabbed subject****Date: April 17, 2026, at 22:29**

Details: Officers were dispatched to a local apartment regarding a suicidal female who had locked herself in a bathroom with several knives. Upon arrival, officers contacted another resident who provided additional information. Officers entered the apartment; one officer had a Taser displayed and another officer had a handgun displayed. The female approached officers and threw her phone at them. Officers then secured their weapons, grabbed the female, and took her to the ground to secure her in handcuffs. The female was transported to a local hospital for an involuntary mental health evaluation.

Charges: None

Demographics: 29-year-old white female

Incident 5:**Use of Force: Grabbed subject****Date: April 18, 2026, at 17:46**

Details: Officers were dispatched to a local apartment complex for a report of disorderly conduct. Officers located a large group of individuals arguing and causing a disturbance in the hallway and began directing the group to disperse. Officers ordered one of the instigators to leave the area; however, he refused and was arrested without incident. While officers were escorting the male to a squad car, another male arrived and refused to comply with commands. Officers grabbed the male and took him to the ground; the male continued to fight with officers. An officer displayed a Taser, which was effective in gaining compliance, and the male was secured in handcuffs.

Charges: Disorderly Conduct, Harassment of Public Official, Interference with Official Acts, Public Intoxication
Demographics: 25-year-old black male, 29-year-old black male

Incident 6:

Use of Force: Grabbed subject

Date: April 26, 2026, at 02:10

Details: Officers were monitoring bar close when they observed a male push another male. Officers grabbed the involved male and secured him in handcuffs without incident.

Charges: Public Intoxication, Disorderly Conduct

Demographics: 22-year-old white male

Incident 7:

Use of Force: Grabbed subject

Date: April 26, 2026, at 02:21

Details: Officers were dispatched to a local residence after receiving a report of a female yelling for help. Officers contacted the caller, who reported a female inside the residence was highly intoxicated and had bitten her. While officers were attempting to gather additional information, the female exited the residence and approached the caller in an aggressive manner. Officers intervened to prevent further injury to the caller. The female was arrested and escorted to the patrol car. The female then resisted and refused to enter the patrol car, and officers grabbed the female and pulled her into the vehicle.

Charges: Assault Causing Bodily Injury, Public Intoxication, Interference with Official Acts

Demographics: 43-year-old black female

Incident 8:

Use of Force: Grabbed subject

Date: April 28, 2026, at 22:09

Details: Officers were dispatched to a local parking ramp regarding an individual threatening suicide. Officers attempted to build rapport with the individual; however, at one point the individual grabbed the railing attempting to pull themselves up to jump. Officers grabbed the individual and took them to the ground to secure them in handcuffs. The individual was transported to a local hospital for a mental health evaluation.

Charges: None

Demographics: 19-year-old black female

Incident 9:

Use of Force: Grabbed subject

Date: April 30, 2026, at 23:52

Details: Officers were dispatched to a local residence for a report of a domestic abuse assault. The male was taken into custody. While officers were escorting the male to the patrol car, he began to resist. Officers gained control by grabbing the male and escorting him to the patrol car. Once inside the patrol car, the male kicked the rear passenger door, causing damage.

Charges: Domestic Abuse Assault, Criminal Mischief 4th Degree, Child Endangerment, Interference with Official Acts

Demographics: 43-year-old white male

*A note on arrests and charges. There is a difference between a discretionary and a non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.

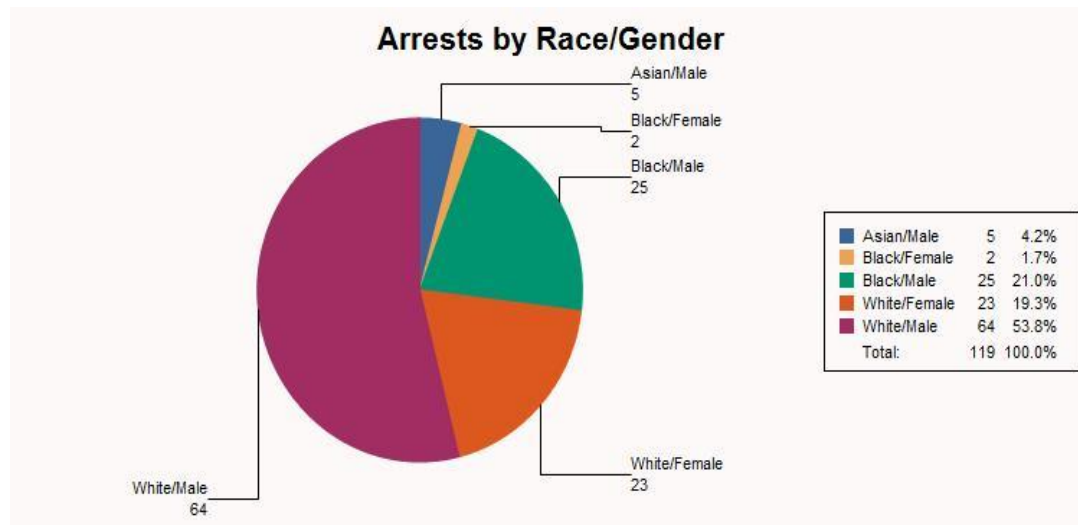
