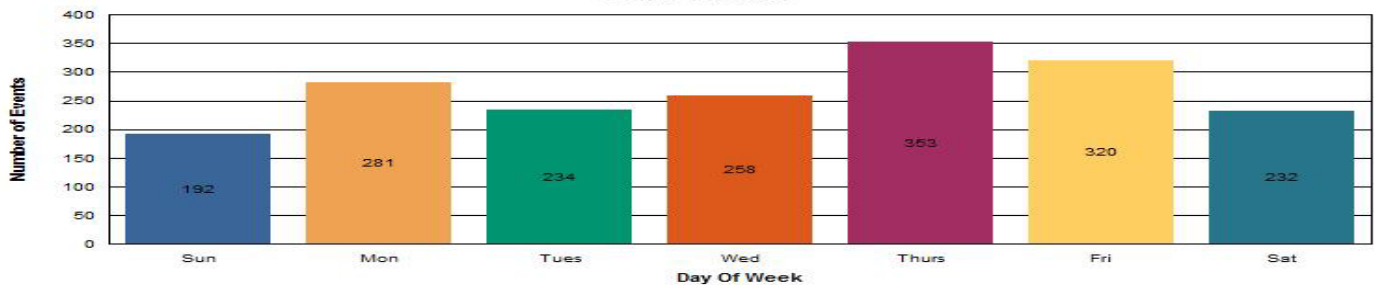

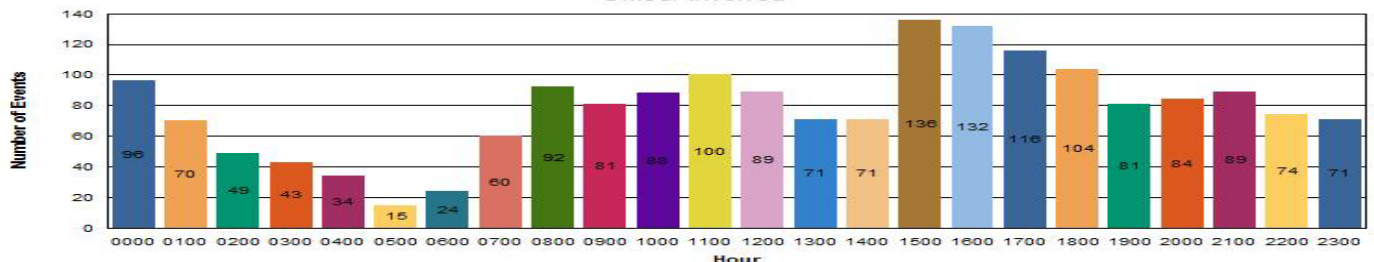

Officer Involved

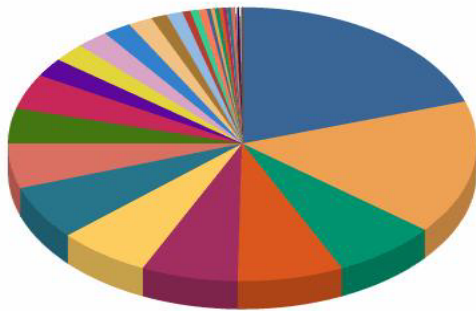


Events by Hour - All Days

USE OF FORCE DETAIL

Incident 1:

Use of Force: Grabbed subject

Date: February 11, 2026, at 22:35

Details: Officers located a male experiencing a medical emergency. For the individual's safety, officers held him on the ground until medical personnel arrived. Officers continued to assist by maintaining the subject in a

safe position while medics provided care. Once stabilized, officers helped medics load the individual into the ambulance for transport to a local hospital.

Charges: None

Demographics: 35-year-old white male

Incident 2:

Use of Force: Grabbed subject

Date: February 13, 2026, at 16:14

Details: Officers were dispatched to a motor vehicle accident. The driver of the vehicle was uncooperative and refused to comply with officers' commands. After exiting the vehicle, the driver pushed an officer, attempting to flee. The officer drew their Taser and ordered the male to comply. As additional officers arrived, they were able to grab the male and secure him in handcuffs without further use of force.

Charges: OWI 1st Degree, Interference with Official Acts, Striking Fixtures Upon a Highway, Failure to Maintain Control, Striking Unattended Vehicle, Failure to Provide Proof of Financial Liability

Demographics: 23-year-old white male

Incident 3:

Use of Force: Grabbed subject

Date: February 25, 2026, at 18:04

Details: Officers were dispatched to a report of an intoxicated male stumbling in and out of the roadway while holding a beer. Officers located the male in the area, and he refused to identify himself and was found to be intoxicated. He was placed under arrest without incident. The male then refused to walk to the patrol car, so officers physically assisted him to the vehicle and into the car.

Charges: Public Intoxication, Interference with Official Acts, Harassment of Public Officials and Employees

Demographics: 52-year-old white male

*A note on arrests and charges. There is a difference between a discretionary and a non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.

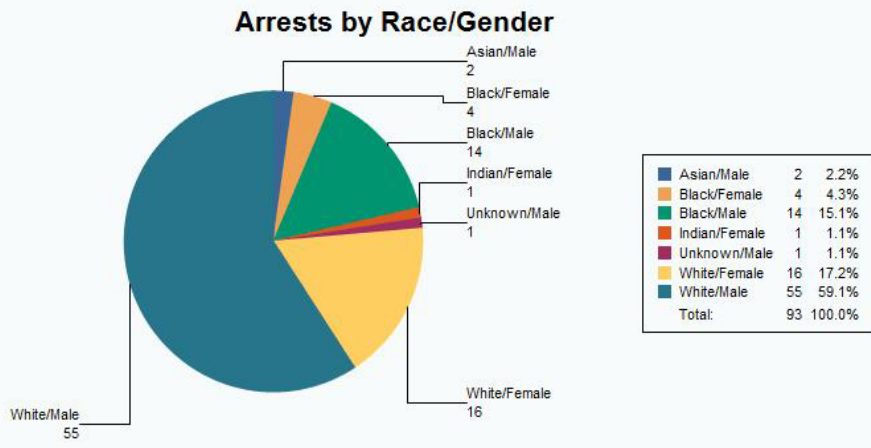
