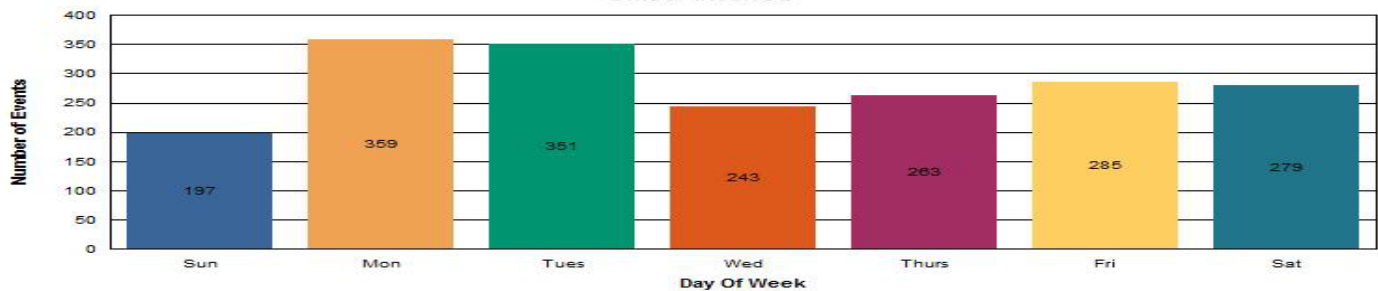

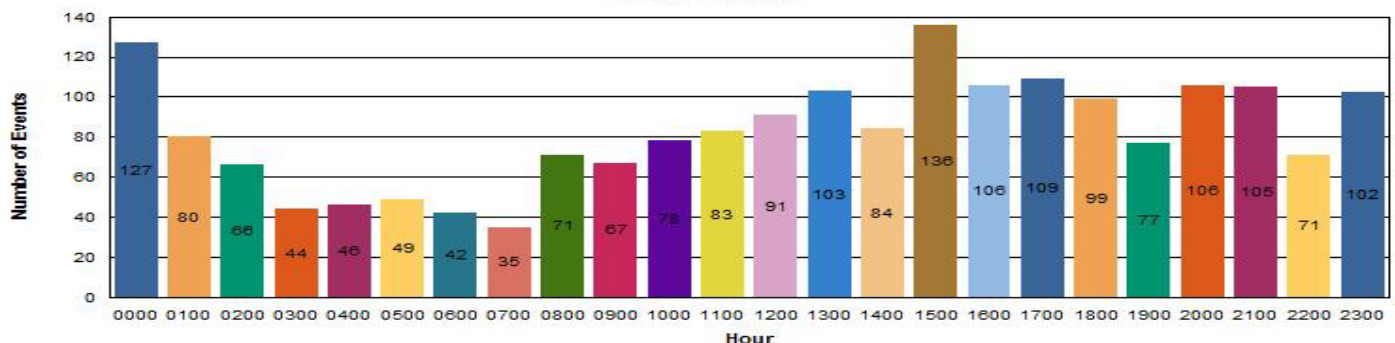

Officer Involved

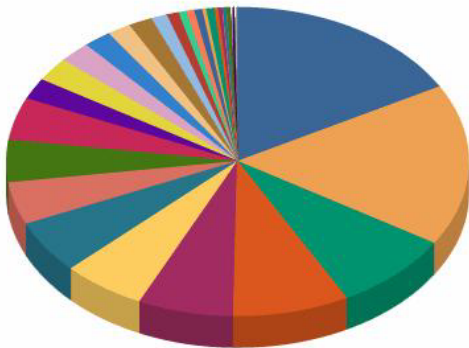


Events by Hour - All Days

USE OF FORCE DETAIL

Incident 1:

Use of Force: Grabbed subject, Taser deployment, ASP deployment

Date: June 6, 2026, at 02:27

Details: Officers were dispatched to a local apartment complex for a report of a male attempting to break into an apartment. Blood was observed throughout the hallway. Upon arrival, officers located the male, who was

covered in blood and armed with a sharp-edged object. The male refused multiple commands to comply, and a Taser was deployed but proved ineffective. The male remained armed and actively resisted officers, resulting in a physical struggle. During the encounter, an officer utilized an ASP baton to strike the male, successfully dislodging the sharp-edged object; however, one officer sustained a cut prior to the male being disarmed. Officers ultimately gained control and took the male into custody after several officers sustained injuries during the incident.

Charges: Assault While Displaying Weapon (Police/Fire), Burglary 1st Degree, Criminal Mischief 4th Degree, Interference with Official Acts

Demographics: 36-year-old white male

Incident 2:

Use of Force: Grabbed subject, OC deployment

Date: June 6, 2026, at 11:12

Details: Officers conducted a traffic stop and determined the driver was operating a vehicle while suspended. The driver was advised he could not drive the vehicle and that it would need to remain legally parked until a valid driver could retrieve it. While the officer was completing paperwork, the officer observed the driver return to the vehicle and drive away, prompting a second traffic stop. The driver parked in a residential driveway, exited the vehicle, and began walking toward the residence while disregarding the officer's verbal commands. When the officer attempted to detain him, the driver resisted, resulting in a physical altercation. The officer deployed OC spray during the struggle and was ultimately able to place the driver in handcuffs and take him into custody.

Charges: Interference with Official Acts, Driving Under Suspension

Demographics: 27-year-old black male

Incident 3:

Use of Force: Grabbed subject

Date: June 9, 2026, at 10:09

Details: Officers were dispatched to a local apartment complex for an unknown incident. Upon arrival, officers located a male who was in violation of a valid no-contact order with the protected party. Officers attempted to take the male into custody. He refused lawful commands and resisted arrest. Officers took the male to the ground to gain control, and during the takedown, one officer sustained an injury. After being placed into custody, the male continued to resist by kicking officers as they attempted to load him into a patrol vehicle for transport.

Charges: Contempt-Violation of No Contact Order, Interference with Official Acts Causing Bodily Injury, Assault on Peace Officer

Demographics: 20-year-old white male

Incident 4:

Use of Force: Grabbed subject

Date: June 24, 2026, at 00:56

Details: Officers were dispatched to a local business for a report of an intoxicated male who was destroying property and had attempted to punch an employee. Upon arrival, officers located the male and determined he was intoxicated. The male was placed under arrest without incident; however, while officers were escorting him to a patrol vehicle, he began physically resisting and officers had to maintain control of him and direct him to continue walking. While being searched next to the patrol vehicle, the male intentionally struck his head and body against the vehicle, causing damage that included dents to the side of the patrol car.

Charges: Public Intoxication, Criminal Mischief 4th Degree, Disorderly Conduct, Interference with Official Acts

Demographics: 23-year-old white male

*A note on arrests and charges. There is a difference between a discretionary and a non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant

Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.

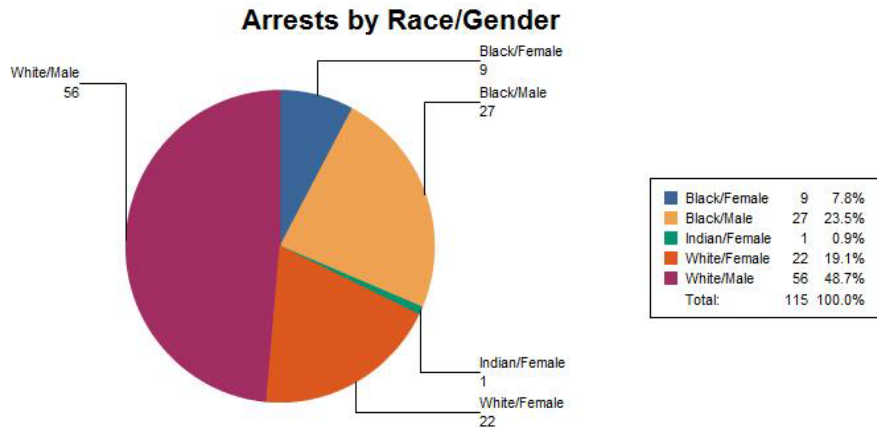
