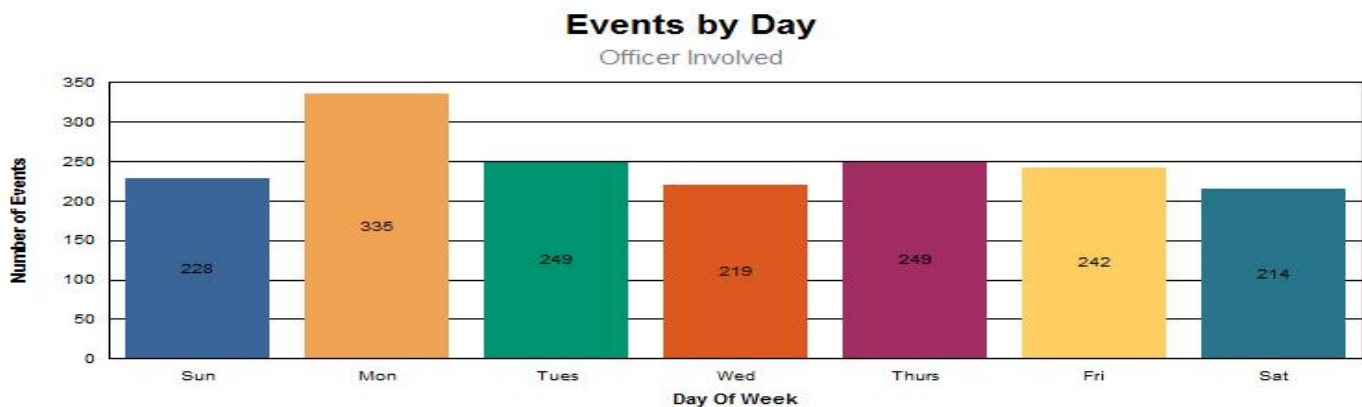

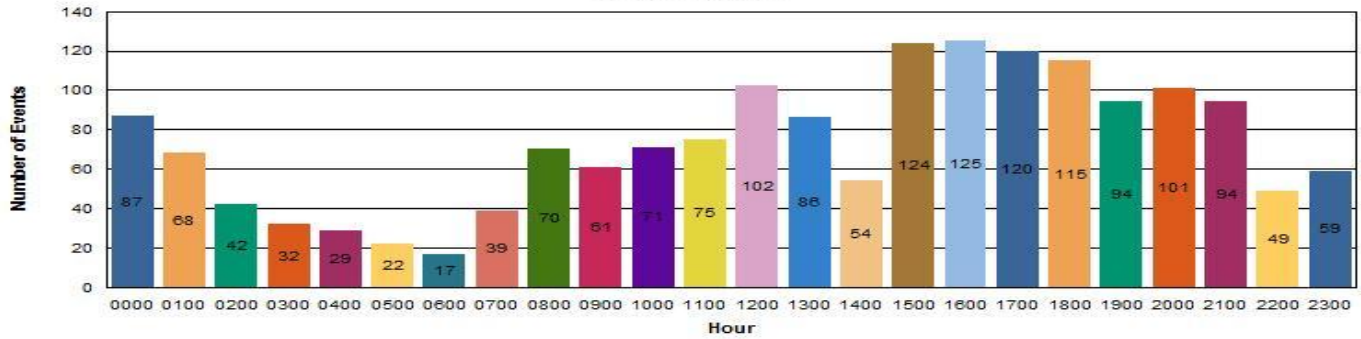

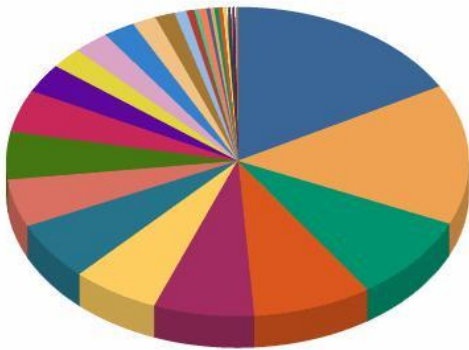
Events by Hour - All Days

USE OF FORCE DETAIL

Incident 1:

Use of Force: Grabbed subject

Date: March 1, 2026, at 20:30

Details: Officers were dispatched to an apartment complex regarding a homeless male sleeping in a stairwell. Upon contact, the male was found to be intoxicated and belligerent. He refused to comply with officers' commands, requiring officers to grab the subject and place his hands behind his back. After one hand was secured in handcuffs, the male began resisting physically. Officers then brought him to the ground to safely secure the subject in handcuffs.

Charges: Public Intoxication, Interference with Official Acts

Demographics: 52-year-old white male

Incident 2:

Use of Force: Grabbed subject

Date: March 2, 2026, at 21:56

Details: Officers attempted to serve an arrest warrant on an individual sleeping outside a local business. The male was intoxicated and required assistance to stand. After standing, he began resisting officers' attempts to place him in handcuffs. Officers grabbed the male and placed his hands behind his back to gain control. During the encounter, the male was found to be in unlawful possession of prescription medications.

Charges: Arrest Warrant, Public Intoxication, Possession of a Controlled Substance, Interference with Official Acts

Demographics: 56-year-old white male

Incident 3:

Use of Force: Grabbed subject

Date: March 4, 2026, at 07:40

Details: Officers were dispatched to a local residence regarding a juvenile male who had threatened to stab his sister. Officers contacted the juvenile, who remained visibly upset. During the encounter, the juvenile picked up a large soda and threw it at his sister. Officers grabbed the juvenile and began escorting him outside to de-escalate the situation. The juvenile subsequently calmed down, and resources were provided to the family.

Charges: None

Demographics: 11-year-old white male

Incident 4:

Use of Force: Grabbed subject

Date: March 8, 2026, at 13:22

Details: Officers were dispatched to a local apartment complex for a fight in progress. Upon arrival, officers located a male who was being disorderly and not complying with verbal commands. Officers attempted to speak with the male; however, he refused to stop walking away. Officers grabbed the male, who continued to resist by pulling away. Officers pinned the male against a vehicle to safely secure him in handcuffs. During the investigation, it was determined the male had taken another individual's phone and posted an explicit video found on the device to his social media account.

Charges: Harassment 1st Degree-Sexting, Disorderly Conduct

Demographics: 28-year-old black male

Incident 5:**Use of Force: Grabbed subject****Date: March 8, 2026, at 16:54**

Details: Officers were dispatched to a local apartment complex regarding a male who was being disorderly by pounding on apartment doors and yelling at residents inside. Officers located the male in a hallway. The male was making incoherent statements and refused to comply with officers' commands. The male then attempted to flee into his apartment, at which point officers grabbed the male. The male fell to the ground during the encounter, and officers were able to gain control and secure him in handcuffs.

Charges: Disorderly Conduct, Harassment 3rd Degree, Interference with Official Acts

Demographics: 38-year-old white male

Incident 6:**Use of Force: Grabbed subject****Date: March 9, 2026, at 15:13**

Details: Officers were dispatched to a local business regarding an assault in progress. While officers were on the way, the male involved fled the scene on foot. Officers located a male matching the suspect description and attempted to stop him in their marked squad cars; however, the male refused to comply with verbal commands to stop. Officers then pursued the male on foot. Officers grabbed the male and took him to the ground to gain control and secure him in handcuffs.

Charges: Criminal Mischief 5th Degree, Assault Causing Bodily Injury or Mental Illness, Interference with Official Acts

Demographics: 21-year-old black male

Incident 7:**Use of Force: Grabbed subject****Date: March 11, 2026, at 00:25**

Details: Officers were dispatched to a fight in progress in the downtown district. Upon arrival, the parties involved began to disperse. Several individuals entered a local bar and were contacted by officers, while others attempted to leave the area and enter nearby vehicles. One individual refused to identify himself and failed to comply with verbal commands. Officers subsequently grabbed the individual who was resisting arrest and took him to the ground and secured him in handcuffs. All other identified individuals were later charged with disorderly conduct.

Charges: Disorderly Conduct, Interference with Official Acts

Demographics: 28-year-old white female, 19-year-old white male, 21-year-old white female, 29-year-old black male

Incident 8:**Use of Force: Grabbed subject****Date: March 11, 2026, at 18:29**

Details: Officers were dispatched to a local business regarding a female refusing to leave the property and being belligerent with customers. The female subsequently exited the business and was contacted by officers outside. Officers attempted to identify the female; however, she refused and continued screaming obscenities while walking away. Officers attempted to stop the female by grabbing her shoulder, but she pulled away and continued to resist. Officers then took the female to the ground to gain control and secure her in handcuffs.

Charges: Criminal Trespass, Interference with Official Acts, Harassment of Public Official or Employee

Demographics: 57-year-old white female

Incident 9:**Use of Force: Grabbed subject****Date: March 12, 2026, at 17:52**

Details: Officers were dispatched to a local business regarding an intoxicated and belligerent female who was yelling at employees and causing a disturbance. Officers located the female outside the business and made contact with her. The female refused to identify herself. Officers determined the female was highly intoxicated and were unable to deescalate her. Officers instructed the female to place her hands behind her back; however, she refused to comply. Officers then grabbed the female and were able to securely place her in handcuffs.

Charges: Disorderly Conduct, Public Intoxication, Criminal Trespass, Harassment of Public Official or Employee, Interference with Official Acts
Demographics: 60-year-old black female

Incident 10:

Use of Force: Grabbed subject

Date: March 13, 2026, at 16:14

Details: Officers were dispatched to a report of a male stumbling in the street and causing vehicles to stop to avoid striking him. Officers located the male on the sidewalk and determined he was intoxicated in public. The male attempted to walk away and failed to comply with officer commands. Officers then grabbed the male and placed him in handcuffs without incident.

Charges: Disorderly Conduct-Obstruct Streets/Sidewalks/Highway, Public Intoxication, Interference with Official Acts
Demographics: 52-year-old white male

Incident 11:

Use of Force: Grabbed subject, Taser deployment

Date: March 13, 2026, at 20:42

Details: Officers were dispatched to a local apartment complex for a report of a stabbing. During the apprehension of the suspect, officers had their duty firearms drawn. Officers deployed a Taser with little to no effect on the suspect. The suspect was taken into custody using a ballistic shield for cover.

Charges: Murder 1st Degree
Demographics: 22-year-old black male

Incident 12:

Use of Force: Grabbed subject

Date: March 16, 2026, at 18:19

Details: Officers were dispatched to a report of a wrong-way driver on Highway 30. Officers located the vehicle on the side of the roadway facing the wrong direction and determined the driver was highly intoxicated. The female refused to exit the vehicle despite the officer's commands. Officers then grabbed the female by the wrists, escorted her out of the vehicle, and were able to secure her in handcuffs.

Charges: OWI 2nd Offense, Interference with Official Acts
Demographics: 37-year-old white female

Incident 13:

Use of Force: Grabbed subject

Date: March 30, 2026, at 18:00

Details: During the execution of an arrest warrant, the subject struck one officer in the face while officers were attempting to control his arms and place him in handcuffs. The male refused to comply with officers and at one point attempted to spit on them and headbutt them. Officers wrestled with the male on his bed and were eventually able to secure him in handcuffs. While escorting the subject outside toward a squad car, he continued to resist and had to be carried out by officers.

Charges: Arrest Warrant, Assault on a Peace Officer or Firefighter, Interference with Official Acts
Demographics: 44-year-old white male

*A note on arrests and charges. There is a difference between a discretionary and a non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.

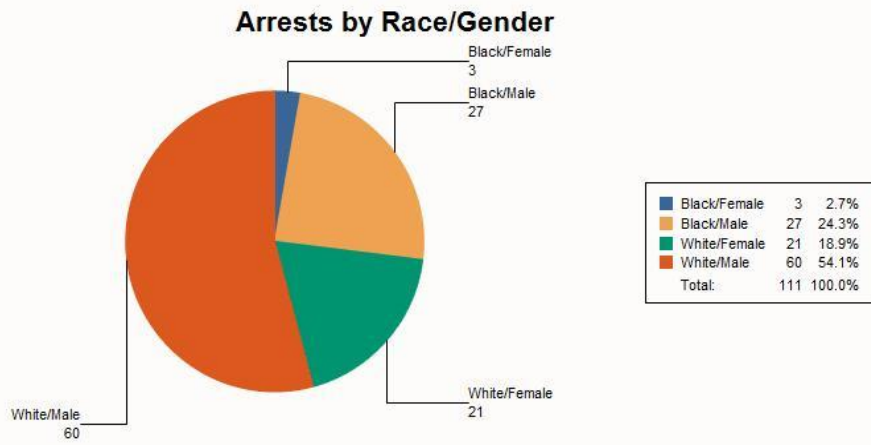
