


Events by Day

Officer Involved




Events by Hour - All Days

USE OF FORCE DETAIL

Incident 1:

Use of Force: Grabbed subject

Date: July 13, 2025, at 16:17

Details: Officers assisted paramedics and firefighters with a combative patient who was suffering from a mental health crisis. The patient threatened physical harm to others and postured in a fighting stance. Officers assisted in restraining the patient so staff could perform medical treatment on the male without being assaulted.

Charges: None

Demographics: 62-year-old white male

Incident 2:

Use of Force: Grabbed subject

Date: July 21, 2025, at 04:02

Details: Officers were dispatched to a residence in reference to an assault. The male was experiencing a mental health crisis. The male charged at officers and, in the process, fell to the ground. Officers placed the male in handcuffs for his safety and the safety of the officers. Officers assisted paramedics in getting the male safely into the ambulance. Once at the hospital, the male was removed from handcuffs and turned over to medical staff.

Charges: None

Demographics: 65-year-old white male

Incident 3:

Use of Force: Grabbed subject

Date: July 21, 2025, at 21:18

Details: Officers responded to a local apartment regarding a trespassing incident. Officers were asked to clear the apartment, as no one had permission to be inside. Inside the apartment, officers located one adult male lying on a bed. The male refused to comply with the officers. Officers grabbed the male's arms and placed them behind his back to secure him in handcuffs. Once secured, another male arrived and entered the apartment. This male was arrested without incident.

Charges: Criminal Trespass

Demographics: 24-year-old white male, 24-year-old white male

Incident 4:

Use of Force: Grabbed and Handcuffed subject

Date: July 25, 2025, at 18:54

Details: Officers responded to a residence in reference to a medical assist where a juvenile male had a rope around his neck and stated he was going to hang himself. As officers arrived, they attempted to calm the male and get him to release the rope. The male did not comply. Officers intervened to prevent the male from hurting himself. Officers grabbed the male's wrists and placed him in handcuffs while they removed the rope from his neck. The male was transported to a local hospital for a mental health evaluation.

Charges: No charges

Demographics: 16-year-old white male

Incident 5:

Use of Force: Grabbed subject, Display of ASP baton

Date: July 26, 2025, at 10:17

Details: Officers responded to a local convenience store for a report of a male assaulting a female. As officers arrived in the area, witnesses pointed officers in the direction of the male suspect. The male took off running but was later apprehended. During the apprehension, the male squared up with officers in a fighting stance. One officer drew their ASP baton and gave the male commands. The male ultimately complied and was secured in handcuffs without incident. The female was later taken to a local hospital for treatment.

Charges: Domestic Abuse Assault-1st Offense, Criminal Mischief 2nd Degree

Demographics: 28-year-old black male

Incident 6:

Use of Force: Display of firearm

Date: July 26, 2025, at 19:33

Details: Officers responded to a local motel for a male and female who were believed to be intoxicated and violating motel rules. Officers were provided with the name of the male. The male had an active protective order against a female. Officers later learned the protected party was the person with the male. The male and female were inside of a motel room and not coming to the door. Due to the circumstances, officers applied for a search warrant for the motel room. Upon entering, officers had their firearms drawn. The male was secured in handcuffs, and no other use of force was used.

Charges: Contempt-Violation of No-Contact or Protective Order

Demographics: 45-year-old white male

Incident 7:

Use of Force: Grabbed subject

Date: July 29, 2025, at 21:43

Details: Officers responded to a local apartment complex to investigate a report of a disorderly male kicking and beating a door to one of the apartments. Multiple calls came in about this male being erratic and screaming. Upon officer arrival, the male jumped on the squad car. It was determined the male was under the influence of some sort of illegal substance. The male was taken to the ground and placed in handcuffs to prevent him from hurting himself. The male was taken by ambulance to a local hospital for treatment.

Charges: Charges pending

Demographics: 23-year-old white male

Incident 8:

Use of Force: Display of firearm

Date: July 31, 2025, at 17:30

Details: Officers conducted a traffic stop on an individual who was known to assault police officers and be armed and dangerous. Officers drew their duty firearms and pointed them at the male. The male complied with orders and was placed into custody without incident. No other use of force was used.

Charges: Controlled Substance Violation-Meth, Possession of Drug Paraphernalia, Drug Stamp Criminal Penalties, Driving While Barred

Demographics: 43-year-old white male

*A note on arrests and charges. There is a difference between a discretionary and a non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.


